COVID TESTING

Thinking about in being tested for Covid-19 exposure? If you are interested in protecting yourself, your loved ones and your fellow citizens, FAST, FREE testing is available at several Pima County locations. The test is a simple painless nasal swab at the Kino and Udall locations and a saliva test at the Flowing wells location. The entire testing is complete in less than 15 minutes. You will have the results in a few days.

Testing is FREE and available at 3 Tucson locations:

- ✓ Kino Event Center, 5805 E Ajo Way
- ✓ Ellie Towne Flowing Wells Community Center, 1660 W Ruthrauff Road
- ✓ Morris K Udall Center, 7200 E Tanque Verde Road

An appointment is required and can be made online at pima.gov/covid19testing. Click on the Schedule My Test link for the desired location.

Drive thru testing is also available on a varying schedule of times and locations which can be found at the same link. This testing is also by appointment only.

Walk up (no appointment) locations are also available, again on a varying schedule of times and temporary locations, also found on the same link.

El Pueblo Center is also offering free testing at the center location, 101 E Irvington Road Building 19. Testing hours at this location are Wednesdays and Saturdays, 7-10am and Mondays. 5-8pm. This location is also by appointment only which can be made by calling (520) 670-3909.

FRED'S TECH-TIPS



SHORE POWER

I have been asked by various folks to have a conversation about plugging our coach into shore power once we arrive at our destination. This may seem to be a nominal event and we do not have much choice once we arrive at a National Park or your typical "campground".

To have a better understanding of this, we first must look at how our coach is configured and the electrical requirements it takes to operate it. Most current coaches have a 50 amp plug but smaller RV's have a 30-amp plug. The difference between a 30 amp plug and a 50-amp plug is not 20 amps. It is 70 amps! Here is the reason why. A 30-amp plug will supply one source of 120 volts with a limit of 30 amperes of power. A 50-amp plug has 2 sources of 120 volts with 50 amperes of power from each source. Therefore, a coach with a 50-amp plug has up to 100 amps of available power to operate all the electrical equipment.

This is not really a concern until you find yourself in a situation where there are no 50 amp plugs available such as a National Park, an older campground, or out in front of your house. This forces you to use your "dog bone" adaptor to step your power cord down from 50 amp to a 30-amp plug. If you must do this, you are forced to be in the energy management mode. Now that you have given up 70 amps of available power, you carefully decide what you can turn on and what you can live without. If you make a mistake the worst that will happen is the inconvenience of "tripping" the 30-amp circuit breaker at the pedestal you are plugged into. Some coaches come with an "energy management system" that automatically turns off equipment that will keep you within the 30-amp resource.

So far, we have been talking in "amps or amperes" however we do not live in an ampere world. We live in a world of "watts". How do we comprehend the difference between amps and watts? Examples would be a "1300-watt microwave" or a "1500-watt hair dryer" or a "1200-watt coffee maker" and so on. Here is the magic formula. Watts divided by voltage equals amperes or amps. This does not have to be an exact science; we can ballpark for every 120 watts that equals 1 ampere. (1500-watt hair drier = 12.5 amps). Enclosed is a chart with the requirements in watts to operate some popular accessories. I suggest that you cut it out and tape it to the inside of a kitchen cabinet door inside your RV for easy reference.

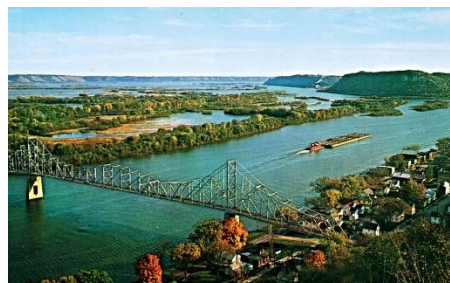
